Community members should be aware that the Board of Supervisors voted this week to put a [County Charter Amendment](#) on the November ballot that would essentially give the Board the power to remove the Sheriff with "just cause." I voted against this motion because I truly believe it dilutes the power of voters. I will always stand in support of law enforcement and know we cannot afford to further distract from public safety.

I find it timely curious that this measure will be on the same ballot as the election for the Sheriff. If voters don't support the Sheriff, an election (or a recall election) is the right course of action. Also, I question why it would only apply to the Sheriff and not all eight elected County positions, including the Assessor, District Attorney, and all five Supervisors. I strongly urge you to carefully consider this issue. I am committed to ensuring the power stays with the people.

# Prioritize Child Safety



Caring for the youth in our community must remain a top priority. This week, our Board approved my motion to support Senate Bill 616, which prioritizes child safety in our family court system by initiating California's path to receive federal funding to protect victims of child abuse and domestic violence. "Piqui's Law" would expand the training needed for judges and court personnel regarding child abuse and domestic violence to equip them with the tools to recognize and respond to abuse, trauma, and violence. This law is a step in the right direction to make sure that when we see abuse, our family law court judges and personnel will be educated to ensure the safety of our most vulnerable children.
